

## **Educational Oversight – Fee Payments for Monitoring Visits - 2024**

**All fees for Educational Oversight are non-refundable.**

ISI is a not-for-profit organisation. ISI does not receive any funding to cover the costs incurred in Educational Oversight and, consequently, the costs of inspection must be borne by the providers.

Inspection fees charged are based on the tariff calculated each year following information submitted by providers in the annual data return. Please note that if inaccurate information is supplied, this may result in further fees being charged or cancellation of the inspection.

Failure to adhere to the strict 14-day payment deadline will result in the cancellation of your inspection and withdrawal from the Educational Oversight cycle.

### **Monitoring Visits**

For the 2024 inspection round Monitoring Visits are applicable to all colleges that in 2023:

- Received a meet expectations judgement in their Monitoring Visit or Educational Oversight inspection;
- Received an exceeds expectations judgement in their Monitoring Visit or Educational Oversight inspection but have subsequently undergone a material change in circumstances. This will result in an Extended Monitoring Visit.

### **Tariffs**

Four tariffs apply and are calculated based on the following criteria:

#### **Tariff O**

- Colleges which predominantly offer EFL courses and are delivering up to 4,000 student weeks of teaching, or fewer, per year;
- Colleges which predominantly offer FE courses and have fewer than 50 full-time equivalent (FTE) students (15 hours per week).

#### **Tariff A**

- Colleges which predominantly offer EFL courses and are delivering between 4,000 and 6,000 student weeks of teaching per year;
- Colleges which predominantly offer FE courses and have between 51 and 99 full-time equivalent (FTE) students (15 hours per week).

#### **Tariff B**

- Colleges which predominantly offer EFL courses and are delivering between 6,000 and 9,000 student weeks of teaching per year;
- Colleges which predominantly offer FE courses and have between 100 and 399 full-time equivalent (FTE) students (15 hours per week).

#### **Tariff C**

- Colleges which predominantly offer EFL courses and are delivering more than 9000 student weeks of teaching per year;
- Colleges which predominantly offer FE courses and have 400 or more full-time equivalent (FTE) students (15 hours per week).

#### **Tariff for Network Providers and Groups**

Organisations which operate on more than one site or which are part of a group will be subject to a separate calculation. Providers falling into this category should highlight this on their annual data return.

### **Educational Oversight – Fee Payments for Monitoring Visits - 2024**

All inspection fees are payable by bank transfer (ISI does not accept cheques under any circumstance) within 14 days of receipt of invoice. **All fees for Educational Oversight are non-refundable.**

#### **Monitoring Visit**

- Tariff O - £2,950.
- Tariff A - £3,210.
- Tariff B - £4,110.
- Tariff C - £4,900.
- Network and group providers will be subject to a separate tariff calculation.

#### **One Day Extended Monitoring Visit**

Extended monitoring visit following material change in circumstances resulting in re-inspection of one section of the Framework.

- Tariff O - £3,700
- Tariff A - £3,950
- Tariff B - £4,800
- Tariff C - £5,750
- Network and group providers will be subject to a separate tariff calculation.

#### **Two Day Extended Monitoring Visit**

Extended monitoring visit following material change in circumstances resulting in re-inspection of two sections of the Framework.

- Tariff O - £6,200
- Tariff A - £6,600
- Tariff B - £8,300
- Tariff C - £9,800
- Network and group providers will be subject to a separate tariff calculation.

#### **Full Inspection**

Full Inspection following material change in circumstances resulting in re-inspection the entire Framework.

- Tariff O - £10,860
- Tariff A - £13,900
- Tariff B - £17,200
- Tariff C - £20,550
- Network and group providers will be subject to a separate tariff calculation.

Please note that this activity is exempt from VAT and therefore no VAT is chargeable.
